Change Order Question for Ultrasound Guided Breast Biopsy to Required & Add N/A Option	 Request to add a required (Hard stop) question to ask if Methylene Blue Dye should be used with the biopsy procedure. It is important for Radiology to know if the dye is needed for the procedure. This can create legal issues for Radiology and extra time calling the Provider to ask the question. This will improve the efficiency of the procedure and safe time for patients, Radiology staff and ordering provider. For the few sites that do not use Methylene Blue there will be a Not Applicable option APPROVED 	No follow up.
Hepatitis C Testing Health Maintenance Topic Patient Population Updated	 To remain current with USPSTF guidelines Hepatitis C Testing Health Maintenance Topic will be updated to display for all patients between the ages of 18 – 79. The guideline recommends a once in a lifetime Hepatitis C screening HCM updates are system wide including Connect sites. Great discussion about allowing options including decline which removes the test forever from HCM and ability to postpone so the topic can be discussed at a later office visit. Since risk factors change during a person's lifetime, discussion included separating the topic into two separate age groups: perhaps an 18 – 40 age group, and a 40+ age group, however if both decline and post pone are options this is not necessary. APPROVED the concept. 	Sandy Hamilton will work on this to test to allow for the same options that are available for the once in a lifetime HIV screening. This topic will then be brought back to a future EPAC meeting for approval.

Standard Dermatology and Standard Consult Note Template	 To help providers documentation support new E&M changes, a standard Dermatology Note template was created. A Standard Consult Note has also been created to support Ambulatory Consultations for both the new E&M coding or for traditional coding since consultations can billed either way depending on the insurance. Unique Standard notes are being created for Specialties require modifications to the Standard Note template. There is a Service Catalog form on Service Now to submit requests for Specialty notes, Smartphrases, smartlists or changes to the Standard notes. The form is called SmartTool Request Providers have the notes available and have been using it in Playground. Go Live for both notes will be June 8th 	No follow up.
EPCS New Vendor	 CentraCare/Carris will be switching to a new vendor, Rapid Identity, for EPCS (Electronic Prescribing of Controlled Substances) by September. Why? Current vendor is sunsetting their product. IS staff will be reaching out to operational leaders to schedule a short 5 or 10-minute setup session with each provider from their group. Dustin Grages will reach out to Connect sites. There will be a new App on phones It can Ping the provider and then they can select an APPROVE/DECLINE button on their phone as one of the two factor authentications for the prescription. No need to transpose a number into Epic with the Ping me function. The Phone app can also generate a number like the previous vendor that is entered into Epic. There is also an option to use a Fob. This will require a new key fob. The Fob functions just like it does now, push a button to generate a number that is put into Epic to be one of the two factor authenticators. We do not currently have the ability in Haiku to prescribe controlled substances with the new Vendor. We are working with the Vendor to encourage them to develop the capacity to use Mobile devices to prescribe controlled substances. Dustin Grages will be working with the Connect Sites. MSHSL Covid Note and Letter	 Smart Texts have been created for providers to help clear students who want to return to sports after having had Covid-19 infection. The new Smart texts are available in Epic a note and a letter option are available. The Smart text was designed to guide providers in completing necessary exam and tests for their patients to be able to return to Sports These forms will be updated as the guidelines from the state MSHSL change. Request to update the current OB Delivery Events/Prenatal Events	 The OB Delivery Labor Events/Prenatal Conditions that are used to document prenatal and delivery details is being revised to better support documentation of the delivery by Providers and nurses. Goal is to capture the prenatal events, labor events and comorbid medical conditions at delivery to reflect the complexity of the delivery and patient care. Information collected in the smart form will flow to both the mom's and the baby's charts through the Delivery summary template and corresponding notes. A system level Clinical expert OB group has been working with Coding, CDI, and compliance to make the changes. Goal is to complete the project by the end of this year. The new Smart Forms will be available system wide for CCH and Connect Sites for OB and FM providers. Discussion on a Proposed Hard Stop for the Reason for a Consult in Consult orders	 The discussion was led by Dr Sharon Ruggiero Reason why there should be a hard stop for the Reason for the Consult is to provide adequate information for the consultative service to prioritize scheduling, provide the services requested by the referring provider, improve patient access and satisfaction with their care and reduce confusion. Issues arise when the Consultants are not clear on the reason for the consult. Despite repeated efforts to education referring providers on the importance of completing the Reason for the consult the comments field is often left blank. 	No follow up.

	 Compliance supports the Hard Stop, without a clear reason for the consults, the consult may not be able to be billed as a consult. A variety of possible solutions were discussed including changing the verbiage on the buttons to address collaborative care or transfer of care for the issue to the specialists, adding a required question for the Reason for the Consult, adding additional smart text to help guide needed information to be completed. This will be a big win for patient satisfaction, for providers, and for compliance. It was decided to mock up some of the ideas and bring them back to a future EPAC meeting.
